

# TWICE THE DEAL PIZZA® TRIP FOR 2 TO CANCÚN MEXICO PROMOTION (PROMOTIONAL RULES)

## CONTEST PERIOD

Twice The Deal Pizza® Trip for 2 to Cancún Mexico (the “Promotion”) commences during Twice the Deal Pizza® operating hours at **12:00:01am Eastern Time (ET) on Monday, October 2<sup>nd</sup>, 2023 and ends at 11:59:00pm ET on Sunday, December 17, 2023** (the "Contest Period"). 1. When you add any drinks to your online order, during the Contest Period, you are automatically entered into the contest.

Transfers from Cancún Mexico airport to the hotel and from the hotel back to the Cancún Mexico airport will also be included. It will be the winner’s responsibility for costs occurred from their place of residence to the Toronto International Airport and back to their residence. Any special Mexican airport taxes will also be the responsibility of the winner.
5. No less than four (4) separate attempts will be made to contact the winner, two (2) attempts by phone and two (2) attempts by email.
6. The winner will have six (6) months from the contest closing date to claim and book their prize. The winner will have one year (1) from the contest closing date to use the all inclusive trip. The trip must be booked a MINIMUM of five (5) months prior to travel due to availability.
